Key Account Terms and Charges				
Monthly Service Charge:	\$10	You will be charged a monthly service fee of \$10 if the average daily balance for a statement cycle falls below \$1,000		
Balance Requirement:	\$1,000	To waive service charge must maintain \$1,000 balance		
Minimum Deposit to Open Account:	\$1,000	There is a \$1,000 minimum balance to obtain the disclosed APY

Orders for Checks:	Varies	Standard The Federal Savings Bank checks and specialty checks vary in cost based on selection; The first set of check orders are free for The Federal Savings Bank checks		
Non-Sufficient Funds (NSF):	\$25 per item	An overdraft fee of \$25.00 will be charged per item for covering overdrafts created by check, in-person withdrawal or other electronic means		

Related Charges (Continued)				
Stop Payment:	\$25 per item	A request by the customer not to honor a specified check drawn on his or her account before it is paid		
Domestic Incoming - Wire Transfer:	\$10	A wire transfer credit that is deposited into your account from another bank account, person, or company		
Domestic Outgoing - Wire Transfer:	\$15	A wire transfer that you send from your account to a person or company		
International Incoming - Wire Transfer:	\$50	A wire transfer credit that is received and deposited to your account from a person or company using an international bank		
International Outgoing - Wire Transfer:	\$50	A wire transfer that you send from your account to an international bank, person, or company		
Excess Per Item Fee:	\$15	Charges per each item in excess of the 6 allowed per statement cycle
